



6. Budget versus Outlook.

A budget is a commitment by management to achieve a revenue level, and the expense pool available to as long as they are achieving that revenue objective. It is also the basis for management's incentive compensation.

An outlook is simply a prediction of what future results will be. The budget was based on an outlook that was realistic at the time it was prepared, reality (outlook) may change, but budgets don't.
