GST Registration Limit



The Goods and Services Tax (GST) is one of the most important tax reforms in India, designed to simplify the tax structure and make it more transparent. Bank Account Details: A canceled cheque or bank statement to verify the business's bank account.

Photographs: Passport-sized photographs of the business owner or authorized signatory.

#### Step 4: Submit the Application

Once you've uploaded the required documents and filled out the details, submit the application. The system will generate an Application Reference Number (ARN), which you can use to track your application.

#### Step 5: ARN Verification

The GST department will verify your application and documents. This process may take a few days. If everything is in order, you will receive your GST registration number and GST registration certificate via email.

## What is GST Registration?

A major benefit of GST registration online is that the process is free. Unlike the old indirect tax systems, there are no additional fees or charges for GST registration. However, there may be additional costs if you hire a professional to assist you with the registration or if you need to use third-party services for document verification.

## GST Registration Limit

Goods Suppliers: Businesses with a turnover of over Rs. 40 lakhs are required to register for GST. However, in special cases such as north-eastern states, this limit can be lower.


Service Providers: Service providers must register if their turnover exceeds Rs. 20 lakhs. Similarly, the limit can vary based on location.

- 3. For Companies: Private or public limited companies will need to submit their certificate of incorporation, along with details of directors and shareholders.
- 4. For E-Commerce Operators: If you're operating through an online marketplace, you'll need to provide proof of your e-commerce business activities, such as contracts or agreements with the marketplace.

Once your GST registration is approved, you'll receive the GST registration certificate and your GSTIN (Goods and Services Tax Identification Number), which must be displayed on all invoices. This number is unique to your business and must be used when filing returns or dealing with other GST-related tasks.
